


Medical Informatics: An Executive Primer

WEBINAR: Telemedicine - Moving Beyond the Video Visit

Presented by Howard Reis President HFAI THEPRACTICES

Telemedicine has become an accepted technology with multiple firms able to provide live video consults with physicians, often presented by companies as a benefit for their employees.

The next frontier is to explore specialty services which are using this same technology and solving major medical problems on a worldwide basis. Patients in El Salvador are having remote

retinal exams to predict instances of diahetes

Second opinions, which require the assembling of multiple data sets (medical records, images, video) are being sent from underprivileged countries with the purpose of providing patients with expert medical advice.

Brand new technology is enabling the review of pap smears from third world countries to determine if patients in under-served areas are likely to have cervical cancer.

Teleradiology, which was the first widely accepted form of telemedicine is now being enhanced with machine learning to improve the radiologist's capability to detect tumors with increased accuracy.

These developments will be presented as brief case studies exploring the potential as well as obstacles.

Delivery System Reform Incentive primary goal of reducing avoidable Payment (DSRIP) Program is a HOT topic for our members!

DSRIP is the main mechanism by which New York State will implement the Medicaid Redesign Team (MRT) Waiver Amendment. DSRIP's purpose is to fundamentally restructure the health care delivery system by reinvesting in the Medicaid program, with the

hospital use by 25% over 5 years. Up to \$6.42 billion dollars are allocated to this program with payouts based upon achieving predefined results in system transformation. clinical management and population health.

New York State's I-STOP mandate effective On March 27, 2016

Tracking Over-Prescribing - Prescription Monitorina Program.

Hear from our Physician Committee Co-Chair Dr. Sam Amifar speak about New York State's I-STOP mandate (effective On March 27, 2016,) requiring electronic prescribing of ALL prescriptions, including controlled substances, goes into effect.

I-STOP/PMP - Internet System for Samuel Amirfar, MD, is the Chief Medical Information Officer and advisor for The Health Situation Room at the Brooklyn Hospital Center where he supports EHR application configuration, population health analytics, and the Wellness Clinic. Dr. Amirfar has published articles in relation to electronic prescribing, clinical decision support systems, the Hub, clinical quality measures, and HIV modeling. Dr. Amirfar also serves on the SHIN-NY/RHIO advi-

sory panel of the Medical Society of the State of New York.

1) How did you get involved in HIMSS?

Earlier this September, I was reading about the innovative collaboration between Airstrip, a health IT software developer, and Apple watch. I visited the Airstrip website and noticed the company prominently displayed their recent exposition at HIMSS 2015 on their homepage. I ended up searching "HIMSS" and read about the organization's many efforts to promote health IT on both the local and national level. As a young clinician looking to engage and network with the health IT community, I felt joining HIMSS would offer me an excellent opportunity to further my career goals.

about my experiences with telehealth and the key issues surrounding its broader implementation. I often hear clinicians complaining about our country's healthcare policies but many never do anything about it. On the other hand, I find legislators are seeking more insight into the challenges facing the healthcare system. For example, many staffers we spoke to were unaware of the geographical limitations on telehealth placed by CMS. It was rewarding to hear them respond "our office did not realize that. We will look into this. Do you know who else in congress we can work on this with?"

tored with a telehealth visit. Clinicians often ask patients to follow up more frequently but do not necessarily take into consideration how challenging that can be. Furthermore, telehealth monitoring has been shown to improve chronic disease management and reduce readmissions for conditions like heart failure. I envision a future where a large percentage of patients will be followed via telehealth. The broader adoption of technology will reduce practice overhead, improve accessibility for patients, and improve health care quality in the United States. It is imperative that CMS and private insurers do more to embrace this technology over the coming years.

2) What has been the most rewarding aspect of your involvement with HIMSS?

While my time with HIMSS has been short, the HIMSS policy summit in October was a highlight of my professional career. I had previously done advocacy work on Capitol Hill, but never had the opportunity to discuss health IT issues. I enjoyed educating policy makers

3) You spoke passionately about Telehealth during the Congressional Office visits during the Public Policy Summit, why?
