On Thursday, April 25, 2013 a CPHIMS training class is being held at Lighthouse International's Bryant Park Room (111 E 59th St, New York, NY 10022).

HIMSS '13: A Student's Perspective

HIMSS13 in New Orleans was a Medical Informatics student's dream.

Attending this conference with close to 35 THOUSAND attendees and more than 1100 exhibitors was comparable to going to Disney World - the prize upon completion of a Masters in Medical Informatics. All of the previously studied healthcare informatics strategies, products, services, and concepts came alive during the first week of March in New Orleans. Of special interest to graduates and jobseekers was the impressive HIMSS Career Services Center featuring speakers including Dr. Ken Ong (Dr. Ong is a HIMSS National Board of Directors' member and former President, HIMSS NYS) and HIT corporate recruiters. Each visitor to the HIMSS 13 Career Services Center

was personally greeted, guided, and encouraged to fully explore HIMSS13. After each lecture in the Career Services Center, the featured speaker was available to individually advise interested jobseekers.

A remarkable feature of HIMSS13 was the upbeat, friendly demeanor of exhibitors, speakers, and HIMSS representatives Everyone was helpful and encouraging in terms of what to visit at HIMSS13, career advice, and how to navigate the country's second largest healthcare convention. It is imperative that HIT students take advantage of the HIMSS special rate allowing student access to innumerable convention



events next year in Orlando! A tip for all students is to study in advance the calendar of speakers, educational sessions, and activities and carefully plan each day at the HIMSS convention - this will maximize the HIMSS experience! HIMSS13 provided many tools to allow for carefully planning online and through the 2013 Resource Guide, HIMSS 13 Daily Insider, and HIMSS 13 Career Guide. These tools made a potentially overwhelming experience manageable and simpler to navigate.

In many ways, attendance at this weeklong event from 8am to 6pm daily was comparable to an intensive semester course in healthcare informatics. It was possible to attend daily: educational sessions, HIMSS13 Interoperability Showcase events, Career Services Center events, and keynote speakers (including President Clinton, Dr. Eric Topol, James Carville, Karl Rove). Educational sessions spanned all HIT topics including Big Data, privacy, security, and supporting underserved communities. It was possible to attend lectures by outstanding speakers everyday including: Dr. Connie Mariano, the White House Physician, and Paul Begala, the political consultant. All speakers gave their perspective of the role and future of HIT.





Networking events also proved to be very valuable learning experiences. Of special interest were the HIMSS NYS Chapter Event, the Women in Health IT Networking Reception, and the Awards Banquet. These events proved to be excellent opportunities to mingle not only with HIMSS members but also exhibitors. Attendees agreed that the two key takeaways of the convention were Interoperability and Analytics. HIMSS 13 was not only an extremely enjoyable experience but also an invaluable tool in career planning. After attendance at the New Orleans convention, this reporter's HIT career path is better defined. The breadth of the HIMSS13 experience was

eye opening and many more career options are now available.

IT and Accountable Care at Mt. Sinai

The Mount Sinai Medical IT has supported the launch of the Accountable Care Organization with multiple innovations. We developed a patient flagging mechanism based on calculations external to Epic, aimed at facilitating care coordination and reducing preventable readmissions. We integrated multiple non-ACO programs that required care coordination into our designs so that all programs were able to leverage the tools and workflows we put in place. Perhaps most importantly, our users were involved at every step of the way in designing workflows and between visit and point of care interventions.

For workflow integration, we implemented 5 chronic disease patient registries: CAD, CHF, Diabetes, COPD, and Asthma and ensured it would meet user needs. We developed the registries with extensive vetting with domain experts, and

then presented the registry designs to a panel of primary care specialists who are the consumers of data and reports from the registries. The registries are designed as a source of care coordination reports, internal quality monitoring, and external reporting requirements for the ACO. In addition to reports, we developed Care Coordinator documentation tools in Epic to support our care coordination team working closely with the Care Coordinators. The Care Coordinators are able to document patient encounters, queue up orders to ensure clinical quality measure adherence, and monitor patients for follow up.

Simultaneous to our ACO launch, multiple care coordination efforts were also well underway such as PACT (aimed at preventing hospital readmissions) and GediWise (aimed at geriatric patients who frequent our Emergency Department). Ensuring that our tools and information were appropriately reused as well as not providing contradictory information was part of the overall design. We implemented a mechanism for flagging patients' readmission risk level as well as participation in one or more of the ACO and care coordination initiatives to aide communication between care coordination teams and improve outcomes. The mechanism for calculating patient risk entailed calculating a risk score based on a modified, HCC-based algorithm, validated by Health Policy studies, and porting that score back into the production EMR to trigger high risk flags.

We have developed over forty reports for improving ACO patient care coordination and monitoring quality measure performance on ACO Quality Measures, by Practice and by Physician. Our near term goal is to enhance our current offering and provide useable and useful self-service Physician panel management reports to further engage our Physicians in population health.

Mt. Sinai is the winner of the HIMSS 2012 Davies Enterprise Award.
