


21st Century Landscape




50 State Medicaid Models Today





The State of Telemedicine in Your Professional Board

- Hold telemedicine to the same standard as inperson care
 - Remote supervision of other health professionals
 - Establishing a provider-patient relationship
 - Prescribing and Dispensing
 - Initial and follow-up visits
 - Telepresenter
 - Patient informed consent
 - Provider and patient location
 - Technology allowed
