UHIMSS Highlight: University of Utah Health Care

University of Utah Health Care was awarded the 2013 Summit Award from 3M Health Information Systems, for their partnership and extensive efforts to implement 360 Encompass, a Computer Assisted Coding (CAC) and Clinical Documentation Improvement (CDI) system. University of Utah Health Care implemented 360 Encompass in March of 2013, becoming the first site in the country on 3M's Release 2 of the product. The 360 Encompass system will help ensure coding accuracy and productivity, and improve clinical documentation and quality measures through the transition to ICD-10 and beyond.

Over the years, University of Utah Health Care has evolved its CDI and coding efforts with the changing health care environment. With the introduction of health care reform initiatives such as ICD-10 and Meaningful Use, and the increase in publicly reported data, coding and CDI has again been forced to reinvent itself. The common thread between all these new initiatives and regulations is error-free, high-quality clinical documentation. High-quality documentation leads to improved clinical outcomes, accurate reimbursement, and a patient record that truly reflects the patient's acuity. While everyone must adhere to these new regulations, University of Utah Health Care is focusing its efforts on improving clinical documentation in a comprehensive way, addressing the root cause, which is not the system or the code, but the specificity employed by health care providers when they document. This focus allows the health care system to meet all of the regulatory challenges at the same time, but more importantly, to change behaviors among health care providers, which becomes the real long-term solution.

Tackling multiple initiatives without increasing staffing is a difficult task, and has forced University of Utah Health Care to become creative and work smarter. 360 Encompass has become a crucial electronic partner in more effectively driving these CDI efforts, ensuring timely coding to support hospital financial strength, and preparing the system for future challenges.

Utah 2014 Legislative Session Preview

I hope you all had a wonderful holiday season! It's hard to believe the 2014 Legislative Session is almost upon us. While many of you may have been busy making new year's resolution, lawmakers have been busy prepping bills they hope will become law this year.

The Legislative Session begins January 27th, and as expected should be very busy on the Healthcare related front. The UHIMSS Advocacy Committee hopes to keep you up to date as the session progresses and provide you a preview here of two bills expected to be voted on this year. We may also issue "Calls to Action" on key legislation if needed. Our committee primarily monitors the Health and Human Services Committees both in the House and Senate via committee meetings open to the public.

Preview #1

Probably the most newsworthy bill will be one sponsored by Senator Stuart Reid (R - Ogden) he is interested in raising the legal age to consume tobacco from 19 to 21 (the age limit was raised in 2010 from 18). SB 12, "Age Limit for Tobacco and Related Products" is the bill he will use to try and move the legal limit. The argument Sen. Reid used was "Increasing the legal age of sale is likely to have a significant impact in reducing tobacco use among the young and limit their access to this highly addictive, deadly product. Young brains are still developing through the teen years and offsetting the daily use of tobacco products will reduce the addiction and dependency on nicotine. Any effort to prevent tobacco use among young people is worthwhile. It will save lives". During the committee hearing on it in November, Senator Todd Weller (R – Woods Cross) countered why 21 is any better or worse than say 25?

Preview #2

Representative Jim Nielson (R – Woods Cross) is bringing back a bill from last year with "Adoption Records Access Amendments". In last year's bill, Nielson was attempting to release original birth certificates of adopted children who were adopted before 1942, and allow birth mothers to release information if they so choose though the Utah State Office of Vital Statistics. Advocates argue that to deny an adult information related to who their birth parents are is unfair to the adopted child—not only from a psychological standpoint, but also in an age of increased genetic testing and knowledge of family history, poses a health risk. Opponents of the bill argue that the mother likely had good reasons to conceal their identity when putting their child up for adoption, and specific request for privacy should be respected.
