Message from the President - The Year in Review

As we head into the final days of 2014 and I reflect on this past year's accomplishments, there are several significant items I would like to point out. First and foremost, our chapter membership grew from just under 1,000 to well over 1,200, growth of nearly 20%. This tells me that our members value the educational opportunities and networking events with their peers. The challenge for the upcoming year will be to continue to deliver outstanding topical education sessions and social events, which brings me to the next accomplishment: state-wide and regional educational events. This year we held one state-wide and six



regional events, where the topics were chosen by you, our members, and delivered in multiple regions throughout the state with more than three hundred members in attendance. In our annual membership survey, you indicated you wanted social events and we delivered. We held two social events (Lil' Ole Winemaker Shoppe in Wausau and Great Lakes Distillery in Milwaukee), and sixty-two members attended these fun events. In our drive to promote and communicate the value of CAHIMS and CPHIMS certification, we conducted three study groups with thirty-nine members participating.

This was an exciting, event-filled year. Our members continue to receive value from their membership, and we look forward to providing you with more exciting educational sessions and social events in the coming year.

In closing, on behalf of the Board of Directors, it is our sincerest wish that you are able to take time to reflect on your personal and professional accomplishments and be blessed with the joy and love of your family and friends during the holidays.

Another Successful Midwest Fall Technology Conference

The 2014 Midwest Fall Technology Conference, a regional collaboration of the six Midwest HIMSS chapters, was held mid-November in Chicago. This annual conference provides a regional forum for members and non-members alike to participate in a robust educational program, an opportunity for professional networking, and a setting in which to engage with technology and solution sponsors. 629 people attended the conference this year, 78 of whom were from Wisconsin (12% of total attendees), and roughly 10% of the vendor sponsorship and participation came from Wisconsin companies as well.

The two day conference included such highlights as five keynote sessions, more than 25 educational sessions, two social events, including an evening at the House of Blues, and a professional development session. The keynote sessions were delivered by renowned healthcare figures and covered well-known, yet impactful and complex, topics such as technology innovation, use of analytics to achieve transformation, C-Suite IT needs, legal implications of HIT, and the emergence of healthcare accelerators and incubators in the Midwest. The educational sessions were a mix of panel discussions, case studies, and more traditional sessions delivered by experienced and talented speakers covering a variety of topics near and dear to many healthcare IT and informatics professionals, such as predictive analytics, patient engagement, HIPAA compliance and security, health information exchanges, improving quality of care, and introduction of newer technologies such as

Results are In for Wisconsin HIMSS 2014 Membership Survey

This past summer, the Wisconsin Dairyland chapter sent out the Annual Survey to chapter members seeking feedback on what types of events, speakers, and topics are of interest to them. We received responses from 12% of the total membership, which is a pretty average response rate to surveys of this type.

A snapshot of the survey respondents shows that 51% of the responses came from people who identified their title as "Director/Manager/Supervisor" or "Analyst/Developer/QA/Support/Technical" with another 8% from C-Level, VP, or higher. 49% of the responses came from people who identified their employer as a provider-type organization such as Hospital, Health System, or Ambulatory Clinic/Center.

The top two (2) reasons for attending a Wisconsin HIMSS event are "Topic or Speaker of interest to me" and "To network with other HIMSS members". In response to networking being one of the top two reasons for attending an event, the chapter leaders added two networking events in July and August 2014 and will look into planning other similar events in the future.

When asked what type of topics you'd like to hear at events, there were several topics that received a significant number of votes. The top eight ranked topics are outlined below, along with the chapter response:

Call for Action: Meaningful Use Legislation

The Meaningful Use 2015 reporting year has begun for Eligible Hospitals (EHs) and is rapidly approaching for Eligible Professionals (EPs). The current requirement for 2015 attestation is one full year of data, which is proving to be a challenge for many organizations as this requirement lacks the flexibility that EHs and EPs need to ensure that they are able to install 2014 certified electronic health record technology (CEHRT) in time.

HIMSS is directing a full grassroots effort to provide a platform for constituents to vocalize their concerns to their senators and members of Congress regarding the current requirement of one full year of data for 2015 and express support for bill HR 5481 Flex IT Act, which would reduce the timeframe to 90 days.

The HIMSS Legislative Action Center (LAC) is a valuable resource to communicate with your legislators regarding your experiences with the 2014 CEHRT and expectations for the 2015 reporting year. Please visit the HIMSS website for the following information on this proposed legislation:
