

HIMSS HOUSTON CHAPTER SCHOLARSHIP POLICY

PURPOSE

The purpose of this policy is to communicate the Health Information Management Systems Society (HIMSS) Houston Chapter's Scholarships criteria and expectations from scholarship recipients who receive a stipend to cover tuition, lab fees, books, and other materials pertaining to degree seeking programs. We provide the scholarship fund through various events and activities that are led by board and volunteer members. Our goal is that scholarship funds will be utilized in a meaningful way to alleviate the financial strains associated with the cost of higher education.

POLICY STATEMENT

It is the policy of HIMSS Houston Chapter to provide guide lines for the selection and allocation of annual scholarships.

SCOPE

The policy covers HIMSS Houston Chapter Scholarship Selection Subcommittee to approve funding for scholarships. Compliance with this policy is the responsibility of all HIMSS Houston Chapter Scholarship Selection Subcommittee, HIMSS Houston Chapter board members, scholarship recipients, scholarship applicants, and all other members/entities associated with scholarship selection process (e.g., schools, recommenders).

TARGET AUDIENCE

The target audience for this policy includes, but is not limited to, stewards and individuals authorized to select HIMSS Houston Chapter Scholarship recipients, scholarship recipients, and all scholarship applicants.

DEFINITIONS

HIMSS Houston Chapter Scholarship: Annual Scholarships provided for National HIMSS and HIMSS Houston Chapter members are based on specific criteria. The number of annual scholarships may vary depending on the funding that is available for the fiscal year.

Scholarship Selection Subcommittee: Members of the subcommittee consist of HIMSS Houston Chapter board members and professors with academic/administrative privileges in higher education.

Scholarship Recipient: The HIMSS Houston Chapter Scholarship is awarded to the recipient during the fiscal year starting June 1 through July 31. The recipient must be enrolled in the school during the fiscal year to receive the scholarship.

PROCEDURE

- 1.1. Responsibilities of the HIMSS Houston Chapter Scholarship Selection Subcommittee:
 - A. The number of scholarship recipients each fiscal year may vary depending on available funds.
 - B. It is the policy of HIMSS Houston Chapter that the Scholarship Subcommittee review all scholarship applicants using objective scoring criteria.
 - B. It is the responsibility of the Scholarship Subcommittee to demonstrate HIMSS core mission to promote and invest in the future of healthcare IT and adhere to our policies and procedures, as well as our high standards for awarding the scholarships.
 - C. It is the responsibility of the Scholarship Subcommittee to demonstrate impartiality without preferential treatments or bias in terms of how the scholarships are awarded.
