- Explain why HIPAA requirements will cause significant changes in policies, procedures and processes within the organization in the handling of patient records.
- Discuss how implementing HIPAA will affect the way healthcare entities organize and staff to achieve and monitor compliance with patient privacy/confidentiality needs.
- Explain how to ensure we are ready for the Health Plan Identifier now being implemented and to see what other initiatives we need to be planning for over the next few years.
- Identify steps through qualifications and positioning strategies for a Chief Privacy Officer and requirements for a Chief Security Officer and review specific Standards and Implementation Specifications within each security category.

HIPAA Certified Professional Certification Training

This Certified HIPAA Professional Certification training helps you better understand HIPAA's Administrative Simplification Act as well as how to create a frame work for initiating and working towards a blueprint for HIPAA compliance. This boot camp is broken into four separate modules. In each one you will learn different aspects of HIPAA. Module 1 gives you an overview of HIPAA, the HITECH Act, and the Omnibus Final rules. Module 2 takes a deep dive into the HIPAA Privacy Rule and stresses what updates have been added in the past few years as the laws, industry, and technology has changed. Module 3 looks at the process we have gone through for electronic transactions, code sets, and identifiers along with recent changes and what is yet to come. In Module 4, you will learn why HIPAA compliance is better focused as a business issue rather than an IT issue, although IT will play a major role in implementing compliant systems. There will be an exam at the end of the course.

A HIMSS member since 2004, Lorna has been the Iowa HIMSS chapters Program Chair from 2006-2011, the Midwest Fall Technology Committee member since 2009, she Co-Chaired Conference in Des Moines in 2012 and was the Chapter President for the 2013-2014 term. She has been a Chapter Task Force Committee member for National HIMSS for the last two years. For the last three years she has also been the Sponsorship Chairperson for the Walk to End Alzheimer's in her community.

She has been the Director of Business Development for ecfirst, home of the HIPAA Academy for the past 12 years although she has worked with the organization since 2001. Her responsibilities include working with Covered Entities and Business Associates doing business with healthcare, throughout the United States and Puerto Rico and now globally in a consulting capacity to provide them with compliance services around HIPAA, ISO, PCI DSS, FISMA and other security regulations to include HITRUST CSF. Lorna has taught a two-day HIPAA Certification course since 2001; delivering training material to both public and private classes with attendees from organizations such as; Ernst & Young, Microsoft, Cerner, Ascension Health, Kaiser Permanente, Cheyenne Regional Medical Center, The Veterans Administration, SmartHealth, Hewlett Packard, McKesson, The Iowa and Illinois Hospital Associations, the States of Iowa, Oregon, Utah and Mississippi, Health Alliance, Flex Benefits and many more. One of her most interesting engagements was in Ghana, Africa for the Health Insurance Authority.

Prior to her position at ecfirst Lorna and her husband Paul owned ExecuTrain; a computer training franchise for 4 years. Prior to that she was in Telecommunications for 14 years overseeing sales and operations in Iowa, Nebraska, South Dakota and Illinois. After several mergers and acquisitions the organization became LDDS WorldCom and finally MCI.
